

**ANALYSIS AND FOLLOW-UP RECOMMENDATIONS  
THE RESULTS OF THE STUDY PROGRAM AND GRADUATES EVALUATION BY  
GRADUATE USERS**

**A. Analysis of The Study Program and Graduates Evaluation By Graduate Users**

The results of the survey for graduate users regarding study program and graduates evaluation, which was conducted in 2020 period (January to December 2020) by the Quality Assurance Group (QAG) of Bachelor of Law Program, Faculty of Law, Universitas Diponegoro, obtained the following conclusions and analysis:

1. The survey is carried out to the agencies/institutions that use graduates of the Bachelor of Law Program in their daily performance activities.
2. The average survey results stated that they were satisfied with the performance of the graduates of the Bachelor of Law Program, Universitas Diponegoro.
3. The results of the survey state that graduates of the Bachelor of Law Program, Universitas Diponegoro already have the qualifications required by the graduate user agency
4. The average number of graduates used by graduate users is 79 people.
5. The results of the survey state that the courses offered in the Bachelor of Law Program, Universitas Diponegoro have been in accordance with the needs of graduate users in order to improve agency performance.
6. The results of the survey state that graduates of the Bachelor of Law Program, Universitas Diponegoro have a good reputation in the graduate user agency.
7. The results of the survey state that the agency has found it easy to access information about graduates through networks and media owned by the Bachelor of Law Program.
8. The survey results state that there are still institutions that have not collaborated with the Bachelor of Law Program Universitas Diponegoro.

**B. Follow-up Recommendations**

Based on the survey results for graduate users regarding the study program and graduates evaluation analysis, it is necessary to take follow-up steps. Therefore, the following are the recommendations given by the Quality Assurance Group (QAG) on the results of the survey for graduate users regarding the study program and graduates evaluation that has been carried out:

1. It is necessary to increase the strengthening of cooperation between the Bachelor of Law Program and various agencies/institutions that have the potential to use graduates of the Bachelor of Law Program in these institutions.
2. The need to improve graduate skills that can be applied in the user job market.
3. The need to adjust required courses in the curriculum is determined based on the job market's needs.

4. The need to prepare Semester Learning Plans (SLP/RPS), which includes case study-based learning methods, is expected to increase the ability and confidence of students in expressing their opinions in public.
5. The need for lecturers to internalize national, moral, and religious values in teaching lecture material.


