## ANALYSIS AND FOLLOW-UP RECOMMENDATIONS THE RESULTS OF THE STUDY PROGRAM EVALUATION BY THIRD PARTY

## A. Analysis of The Study Program Evaluation By Third Party

Professions from several agencies/institutions, both government and private. Results of evaluation surveys by Third Parties in 2019-2020 period, consisting of various professions from several agencies/institutions with due observance of four assessment points which include: a. Study Program Assessment; b. Assessment of Access to Information; c. Media Ratings; d. Cooperation Assessment; and e. Reputation Assessment, which has been carried out through an official questionnaire from the Bachelor of Law Program, shows good results:

1. Study Program Assessment

Based on the assessment survey of the study program, it shows that the average rating is very good with a percentage of 100%. This result is the overall score obtained from all respondents, which focuses on the friendliness of the administrative officers, speed of service, and ease of access in contacting the Study Program. Therefore, the three indicators described above reflect a very good score.

- 2. Information Access Assessment At this point of assessment, a 100% percent is obtained, determined by two assessment criteria: the ease of accessing the Bachelor of Law Program information and responsiveness in providing information. These results show that the overall answers show a very good assessment.
- 3. Assessment of Media

In the context of information related to the Bachelor of Law Studies Program in various media, the percentage obtained is 86%. The survey results show that most respondents have received comprehensive information about the study program from social media, online media, print media, and verbal information. The Quality Assurance Group of The Bachelor of Law Program, Faculty of Law, Universitas Diponegoro, concluded that the study program's provision of information media equipment showed a fairly good performance.

4. Assessment of Cooperation

The results of the survey regarding cooperation with stakeholders obtained a percentage of 71% of all respondents. These results show that the assessment of cooperation with third parties has not been maximized but is good enough.

5. Assessment of the Study Program's Good Reputation Based on the results of a survey conducted at several agencies/institutions and several respondents, it was shown that the Bachelor for Law Program obtained a 100% presentation rating. These results indicate a very good assessment and indirectly describe the good image of the Bachelor for Law Program in front of stakeholders.

## **B.** Follow-up Recommendations

Based on the analysis of the results of the survey for the third party regarding study program evaluations that have been carried out, the Quality Assurance Group (QAG) of the Bachelor of Law Program recommends the following:

- 1. It is necessary to increase cooperation with various parties, government agencies, and private institutions in building a wider network.
- 2. The need to improve the quality of the study program by increasing publications, socialization, increasing the introduction/promotion of the Bachelor of Law Program in various media to increase the interest of prospective students in the study program.
- 3. The need to strengthen and realize the cooperation to be more effective in providing information related to the Undergraduate Study Program.

Thus the analysis of the results of the third-party survey regarding study program and graduates evaluation and follow-up recommendations given by the Quality Assurance Group (QAG) of the Bachelor of Law Program, Faculty of Law, Universitas Diponegoro, in order to be followed up for maintaining the quality of the learning process in the Bachelor of Law Program, Faculty of Law, Universitas Diponegoro.
